TENDER SUMMARY AND REQUIREMENT

The Hong Kong Kart Club (HKKC) is to select a range of suitable circuits for hosting the year 2017 Hong Kong Kart Club (HKKC) Championships and Trainings. The circuit to be selected will also need to supply competition kart tyres at each Race or Training.

Interested parties are hereby invited to tender to become the supplier of the circuit and the competition kart tyres for each Race or Training. The selected tenderer will be invited to enter into a contract with the HKKC that will establish the terms of the tenderer's appointment as a non-exclusive supplier. The supplier will supply the circuit with the relevant services and facilities required at each Race or Training under the terms and conditions to be agreed with HKKC. It will also supply the competition kart tyres at each Race or Training under the terms and conditions to be agreed with HKKC as well. Bids must be submitted in accordance with the tender requirements as below. HKKC reserves the right to make amendments to this invitation to tender at any time and to issue a new invitation to tender.

PART 1 - GENERAL CONDITIONS
RECITALS

(A) The ORGANIZER is the National Sporting Authority (NSA) on Karting for Hong Kong Special Administrative Region.

(B) The PROVIDER is a licensed and operating Karting Circuit located in:

(C) It is intended that the ORGANIZER and the PROVIDER will enter into this CONTRACT pursuant to which the PROVIDER will be appointed as a NON-EXCLUSIVE supplier of the CIRCUIT and the COMPETITION KART TYRES for the 2017 HONG KONG KART CLUB CHAMPIONSHIPS AND TRAININGS for the term set out herein.

1. APPOINTMENT AND SUPPLY

1.1 The ORGANIZER hereby appoints the PROVIDER as a non-exclusive supplier of the CIRCUIT and the COMPETITION KART TYRES for the 2017 HONG KONG KART CLUB CHAMPIONSHIPS AND TRAININGS and The PROVIDER hereby accepts this appointment and agrees to supply the CIRCUIT and the COMPETITION KART TYRES for the CHAMPIONSHIPS AND TRAININGS in accordance with the terms of this NON-EXCLUSIVE SUPPLY CONTRACT and the terms of the NON-EXCLUSIVE SUPPLY AGREEMENTS.

1.2 The CIRCUIT as well as the services and facilities that is supplied by the PROVIDER to the ORGANIZER shall be in strict compliance with the SPECIFICATIONS OF THE CIRCUIT.

1.3 The COMPETITION KART TYRES that is supplied by the PROVIDER to the ORGANIZER shall be in strict compliance with the SPECIFICATIONS OF THE COMPETITION KART TYRES.

2. RELATIONS BETWEEN THE PROVIDER AND THE ORGANIZER

2.1 The PROVIDER shall ensure the CIRCUIT AND the COMPETITION KART TYRES supply to the ORGANIZER is legal, and compatible with this CONTRACT.

2.2 The ORGANIZER may request cancellation to this CONTRACT if it considers that the CIRCUIT OR the COMPETITION KART TYRES is illegal and incompatible with this CONTRACT.

3. LIABILITY

3.1 Without prejudice to the ORGANIZER's other rights, the PROVIDER shall indemnify and hold harmless the ORGANIZER from and against all reasonably foreseeable losses incurred by the ORGANIZER as a direct result of the PROVIDER's:

- (a) Failure to supply the CIRCUIT OR meet the SPECIFICATIONS OF THE CIRCUIT at the date as specified in this CONTRACT;

- (b) Failure to supply the COMPETITION KART TYRES OR meet the SPECIFICATIONS OF THE COMPETITION KART TYRES at the date as specified in this CONTRACT;
- (c) Negligence in the supply of the CIRCUIT OR meet the SPECIFICATIONS OF THE CIRCUIT at the date as specified in this CONTRACT; and
- (d) Negligence in the supply of the COMPETITION KART TYRES OR meet the SPECIRICATION OF THE COMPETITION KART TYRES at the date as specified in this CONTRACT;

3.2 The PROVIDER represents and warrants that it is in a position to meet any liability that may arise under clause 3.1 of this CONTRACT up to an amount of HKD170,000 (ONE HUNDRED SEVENTY THOUSAND Hong Kong Dollars) per event and hereby covenants to maintain such position for the period of time during which the PROVIDER may be liable.

4. WARRANTIES

4.1 The PROVIDER represents and warrants that it has full power and authority to enter into and fully perform its obligations under the CONTRACT and the provisions of the CONTRACT, when executed, will constitute valid and binding obligations on the PROVIDER in accordance with its terms.

5. TERMINATION

5.1 Notwithstanding any other provision hereof, either party may terminate the CONTRACT with immediate effect by written notice to the other if any of the following events occur:

- (a) the other party has committed a material breach of the CONTRACT which is not capable of remedy or, if remediable, has not remedied it within 30 days of the non-breaching party's written notice requiring the default to be remedied (for the avoidance of doubt, a breach by the PROVIDER of any of GENERAL CONDITIONS 1.2, 1.3 2.1, 3 and 4.1 and any of SPECIAL CONDITIONS is acknowledged by the parties to be a material breach);

(b) steps (including any steps analogous to those following) have been taken to wind up the other party or to place the other party into administration or to have a receiver appointed over any of its assets, other than as part of a scheme of solvent reconstruction or amalgamation; or

(c) the other party shall cease or threaten to cease carrying on business or the other party shall make any composition or arrangement with its creditors or become subject to any other insolvency process or proceeding (other than as part of a scheme of solvent reconstruction or amalgamation) or have all or any of its assets or undertakings seized by a government or governmental agency or authority (including any acts analogous to the above).

6. GOVERNING RULES

6.1 The GOVERNING RULES constitute the legal, administrative and technical framework of the CHAMPIONSHIPS AND TRAININGS and the conditions set forth therein shall have binding force and prevail among the parties to the CONTRACT.

6.2 The PROVIDER acknowledges that the SPECIFICATION OF THE CIRCUIT OR the SPECIFICATIONS OF THE COMPETITION KART TYRES as well as the GOVERNING RULES are subject to amendment from time to time.

7. GOVERNING LAW AND LANGUAGE

7.1 The language that shall prevail for the interpretation of the CONTRACT shall be English and the CONTRACT and all documents connected with the CONTRACT shall be written in English. In the event of any conflict between the language of the CONTRACT and any translation thereof, the language of the CONTRACT, English, as the case, shall prevail.

7.2 The governing law of the CONTRACT shall be Common Law.

7.3 The Parties shall endeavor to settle amicably by mutual discussions to resolve any disputes, differences, or claims whatsoever related to this Contract.

7.4 Failing such amicable settlement, any controversy or claim or dispute arising under or relating to this Contract, including the existence, validity, interpretation, performance, termination or breach thereof, shall finally be settled by arbitration in accordance with the International Arbitration Rules of LCIA Rules. Unless the Parties agree to a sole arbitrator, there shall be three (3) arbitrators, with each Party appointing one (1) arbitrator, who collectively will select a third. The language of the arbitration shall be English. The Arbitrator will not have authority to award punitive damages to either Party. Each Party shall bear its own expenses, but the Parties shall share equally the fees and expenses of the Arbitration Tribunal. This Contract shall be enforceable, and any arbitration award shall be final, and judgment thereon may be entered in any court of competent jurisdiction. The arbitration shall be held in Hong Kong, S.A.R.

8. GENERAL

8.1 No delay or omission or failure to exercise any right or remedy provided herein shall be deemed to be a waiver thereof.

8.2 The CONTRACT shall be binding on and ensure to the benefit of the parties and their respective successors and permitted assigns. The PROVIDER shall not be entitled to assign or sub-contract its rights or obligations under the CONTRACT in whole or in part without the prior written consent of the ORGANIZER.

8.3 Any notice to be given under the CONTRACT shall be given in writing delivered to the other party by any one or more of the following methods:

(a) Personal delivery to one of its corporate officers, in which case notice shall be treated as having been given at the time of such personal delivery;

(b) first class registered post or courier delivery service (such as DHL or UPS) to the address mentioned above (or such other address as may be notified to the other party in writing from time to time), in which case notice shall be treated as having been given on the date of actual receipt at that address (or on the next local business day if delivered on a local non-business day or after 4.00 p.m. local time on a local business day), which shall rebuttably be presumed to be the second local business day after posting; or

(c) facsimile to the numbers below (or such other facsimile number as maybe notified to the other party in writing from time to time), in which case notice shall be treated as having been received at the time of actual receipt (or on the next local business day if delivered on a local non-business day or after 4.00 p.m. local time on a local business day) and rebuttably be presumed to have been duly received at the time indicated on the automatic acknowledgement transmitted by the recipient fax machine:

8.4 Any variations of the CONTRACT shall be ineffective unless agreed in writing and signed by the parties.

8.5 If any term, provision or condition of the CONTRACT is held by a court of competent jurisdiction to be invalid, void or unenforceable such invalidity, voidness or unenforceability shall not invalidate the remainder of the CONTRACT, all of which shall remain in full force and effect.

8.6 The CONTRACT may be executed in any number of counterparts (whether original or facsimile counterparts) and upon due execution of all such counterparts by all parties, each counterpart shall be deemed to be an original hereof.

8.7 GENERAL CONDITIONS 2 shall survive expiry or termination of the CONTRACT for any reason (but shall terminate at the time expressly provided in the relevant GENERAL CONDITION, if any).

PART 2 - SPECIAL CONDITIONS

1. PROVISION OF CIRCUIT AND COMPETITION KART TYRES

1.1 The PROVIDER shall provide the CIRCUIT AND the COMPETITION KART TYRES at a non-exclusive basis for the 2017 HONG KONG KART CLUB CHAMPIONSHIPS AND TRAININGS.

1.2 The PROVIDER shall provide the CIRCUIT AND the COMPETITION KART TYRES as required by the ORANIZER at ONE (1) calendar day prior to any RACE or TRAINING (CHAMPIONSHIPS AND TRAINING calendar in Appendix 1). The ORGANIZER reserves the right to test the COMPETITION KART TYRES at the CIRCUIT ONE (1) calender day prior to any RACE or TRAINING.

1.3 The COMPETITION KART TYRES provide by the PROVIDER shall be of a strictly uniform quality throughout the duration of each RACE or TRAINING.

1.4 The ORGANIZER does not guarantee the PROVIDER a minimum number of RACE nor TRAINING to be held nor guarantee the quantity of COMPETITION KART TYRES to be supplied by the PROVIDER. The ORGANIZER has the sole discretion to cancel or reschedule any RACE or TRAINING TWO (2) CALENDER WEEKS before any RACE or TRAINING begins.

1.5 The PROVIDER undertakes to provide the CIRCUIT in accordance to the conditions stipulated in the SPECIFICATIONS OF THE CIRCUIT.

1.6 The PROVIDER undertakes to supply one type of “dry weather” COMPETITION KART TYRES OR one type of “wet weather” COMPETITION KART TYRES that must be capable of covering a minimum of distance during the same RACE or TRAINING as specified in the PRICING FORM, respecting absolutely the performance and safety conditions stipulated in the SPECIFICATIONS OF THE COMPETITION KART TYRES.

1.7 The PROVIDER shall ensure that the representative of the PROVIDER are present at-the-circuit at all time during each RACE or during each TRAINING.

2. DELIVERY OF THE PRODUCT

2.1 The COMPETITION KART TYRES supplied by the PROVIDER shall be made available at the specific track no later than ONE (1) calendar day prior to the starting date of the RACE or TRAINING listed in Appendix 1.

3. STANDARDS AND CONDITIONS OF THE CIRCUIT AND THE COMPETITION KART TYRES

3.1 The PROVIDER shall provide to the ORGANIZER the detail and the layout of the CIRCUIT listed in the SPECIFICATION OF THE CIRCUIT for the approval of the HKKC COMMITTEE. In the event that an amendment to the detail and layout of the CIRCUIT supplied pursuant to the CONTACT, the PROVIDER shall provide to the ORGANIZER a detail description of the amended CIRCUIT to be supplied pursuant to the CONTRACT to take account of such amendment.

3.2 The PROVIDER shall provide to the ORGANIZER the technical specifications of the COMPETITION KART TYRES for the approval of the HKKC COMMITTEE. In the event that an amendment to the technical specifications of the COMPETITION KART TYRES supplied pursuant to the CONTACT, the PROVIDER shall provide to the ORGANIZER a detailed technical specifications of the amended COMPETITION KART TYRES to be supplied pursuant to the CONTRACT to take account of such amendment.

3.3 Technical checks may be carried out on samples taken either directly from the PROVIDER or during the RACE or TRAINING (COMPETITION KART TYRES used by the COMPETITORS OR PARTICIPANTS during the running of the RACE or TRAINING) comparing the quality of the COMPETITION KART TYRES distributed with that of the samples taken.

4. PRICING OF THE CIRCUIT AND THE COMPETITION KART TYRES

4.1 The price of the CIRCUIT supplied pursuant to the CONTRACT to the specific track of each RACE shall be:

5. RIGHTS OF PROMOTION

5.1 The ORGANIZER maintains the right (including any advertising, publicity or other promotional activity) to promote the RACE, TRAINING and the CHAMPIONSHIPS.

5.2 The PROVIDER is prevented from advertising, publicizing or otherwise promoting in any form whatsoever, including either direct or indirect advertising, via any media, and in any country, or its relationship with the RACE, TRAINING or CHAMPIONSHIPS. All phases of PRODUCT delivery pursuant to the CONTRACT shall be carried out by personnel wearing no distinctive symbols or designs on their uniforms and using equipment that does not give any indication as to the identity of the PROVIDER, with the exception that the ORGANIZER has given the permission in writing.

PART 3 – DEFINITIONS

The following terms shall be understood to have the following meanings for the purposes of the "CONTRACT".

1.1 **CHAMPIONSHIPS** means the year 2017 HONG KONG KART CLUB CHAMPIONSHIPS.

1.2 **CIRCUIT** means the circuit, including all facilities and services provided within the vicinity of the circuit, as such word is described in the REQUIRMENT OF THE CIRCUIT.

1.3 **CONTRACT** means the GENERAL CONDITIONS, the SPECIAL CONDITIONS and the DEFINITIONS.

1.4 **COMPETITION KART TYRES** means tyres, as such word is described in the REQUIRMENT OF THE COMPETITION KART TYRES.

1.5 **COMPETITORS** means the racing teams or drivers that have been accepted by the ORANIZER to take part in the **RACE**.

1.6 **DEFINITIONS** means the definitions set out in this Part 3 of the **CONTRACT**.

1.7 **HKKC COMMITTEE** means the committee members of the ORGANIZER to carry out all technical checks and controls and to grant the necessary approval prior to the starting up of production.

1.8 **GENERAL CONDITIONS** means the provisions contained in Part 1 of the CONTRACT.

1.9 **GOVERNING RULES** means:

(a) the General Prescriptions applicable to the HKKC Championships,

(b) the SPORTING REGULATIONS; and

(c) the TECHNICAL REGULATIONS;

1.10 **ORGANIZER** means the HONG KONG KART CLUB LIMITED (HKKC)

1.11 **PARTICIPANTS** means the drivers that have been accepted by the ORGANIZER to take part in the **TRAINING**

1.12 **PRICING FORM** means the pricing form provided at **Appendix 2** stating the prices at which the CIRCUIT will be supplied at each RACE and TRAINING, (including the OFFICIAL TESTING, if any, to the COMPETITORS), the prices at which the COMPETITION KART TYRES will be supplied at each RACE and TRAINING.

1.13 **PRINCIPLES OF SPORTING EQUALITY** means the equal treatment by the PROVIDER of all COMPETITORS with respect to:

(a) anything which may affect the performance of the COMPETITION KART TYRES;

(b) the terms on which the COMPETITION KART TYRES is supplied;

(c) the support, access and information made available to the COMPETITORS in relation to the CIRCUIT AND COMPETITION KART TYRES; and

(d) any other matter which affects or may have an effect, however minor, on sporting performance.

1.14 **PROVIDER** means [•] _____

1.15 **RACE** means any RACE forming part of the CHAMPIONSHIPS. The **RACE** is deemed to commence at the scheduled time for scrutineering and sporting checks and includes all practice, qualifying and the RACE itself and ends at the expiry of the deadline for the lodging of a protest under the terms of the International Sporting Code.

1.16 **SET** means a set of four tyres.

1.17 **SPECIAL CONDITIONS** means the provisions contained in Part 2 of the CONTRACT.

1.18 **SPECIFICATIONS OF THE CIRCUIT (Appendix 4)** means the detail and specifications of the CIRCUIT.

1.19 **SPECIFICATIONS OF THE COMPETITION KART TYRES (Appendix 4)** means the specifications of the homologation form of the **COMPETITION KART TYRES**.

1.20 **SPORTING REGULATIONS** means the Sporting Regulations applicable to the CHAMPIONSHIPS as published and amended by the ORGANIZER from time to time.

1.21 **TECHNICAL REGULATIONS** means the Technical Regulations applicable to the CHAMPIONSHIPS as published and amended by the ORGANIZER from time to time.

1.22 **TRAINING** means any TRAINING hosted by the **ORGANIZER**.

- 5. Provision of no less than One (1) CIRCUIT REPRESENTATIVE at all time during the RACE or TRAINING for the on-circuit decision making and being the communication point between HKKC and the CIRCUIT.**
- 6. Provision of no less than Two (2) OFFICE CLERK at all time during the RACE or TRAINING for the purpose of sign-in, registrations and general enquires, etc.**
- 7. Provision of no less than One (1) Qualified Medical Officer at all time during the RACE or TRAINING.**
- 8. Provision of no less than One (1) Emergency Vehicle for emergency transportation from CIRCUIT to Hospital.**
